Student admission criteria for specialist medicine and specialist dentistry education and number of study places for the 2022–2023 academic year

Under section 36 of the Universities Act (558/2009), the university decides on the principles for student admissions. In accordance with section 9.4 of the UEF University Regulations, the Faculty Council is tasked with deciding on curricula, degree requirements, and the admission criteria for students. Decree 56/2015 of the Ministry of Social Affairs and Health (amended by Decree 55/2020) defines the requirements and admission criteria for professional postgraduate education. The uniform national student admission criteria shall apply to professional postgraduate education.

The faculties that provide professional postgraduate education in medicine and dentistry in Finland prepared student admission criteria for specialist physician and specialist dentist education in spring 2022. The current student application and admission procedure has been used for specialist physician and specialist dentist education since 1 January 2019, and the student admission criteria have been reviewed and developed in nationwide collaboration after each round of admissions. Appendix 1 contains the proposal to the Faculty Council on the student admission criteria for the 2022–2023 academic year. Summary of the changes:

The number of study places in all fields of specialisation shall be decided upon in June for the entire academic year, ready for the main application round in the autumn. However, the number of study places for general medicine and occupational health care each academic year shall be divided between the main application round in the autumn and the additional application round in the spring in a proportion decided upon by each specialisation.

- Interview

- The person responsible for the specialisation decides whether to conduct the interview in person or via a remote connection.
- The following was added to the student admission criteria concerning the language of the interview: "Irrespective of the university, the person responsible for the specialisation may decide to conduct the interview entirely in Swedish if the person responsible deems it possible to complete the education predominantly in Swedish (e.g., study places in Åland)."

Approval of the study guides and curricula for specialist medicine and specialist dentistry education

In accordance with section 9(4)(4) of the EUF University Regulations, the Faculty Council is tasked with deciding on curricula, degree requirements, and the admission criteria for students. The faculties that provide dental education in Finland have worked in nationwide collaboration to prepare study guides for specialisation education, which are submitted to the Faculty Council.

The national study guides and consultation requirements for specialist physician and specialist dentist education in accordance with Decree 55/2020 of the Ministry of Social Affairs and Health were updated in spring 2020, and they are valid until further notice. A separate Evaluation of Expertise guide is valid for one academic year at a time, and the content is updated annually.

All of the specialisations in specialist physician and specialist dentist education updated the Evaluation of Expertise guide in spring 2022. In the Evaluation of Expertise guide for the 2022–2023 academic year, the National Committee on Professional Postgraduate Education (VAJT) set the target of at least five evaluations of Entrustable Professional Activities (EPAs) in use in every specialisation.

Granting of a separate right for Ukrainian university students to study in the Faculty of Health Sciences at the University of Eastern Finland due to the acute humanitarian crisis

According to section 7(1) of the Universities Act (558/2009), universities may provide professional specialisation programmes, degree modules as open university education or as other non-degree studies, and continuing professional education in addition to degree programmes. According to section 12 of the University of Eastern Finland's Study Regulations, the Faculties may grant a separate right to study the courses they teach if there is a justified reason for doing so.

A student with a valid right to study at a Ukrainian university may apply for the right to study upon arrival in Finland. A study right may be granted to a person who has come from Ukraine to Finland and received a temporary protection decision. The granting of study rights is based on the phase of study (Bachelor's or Master's studies) and the compatibility of the courses that the student has already completed in relation to the education provided at the University of Eastern Finland. The student must be proficient in English. Students may be interviewed to verify their language skills and the suitability of their prior studies. The application should state the applicant's language skills, the discipline in which the prior studies were completed, and the number of courses, as well as any other grounds for the application. A copy of the passport or an equivalent document should be appended to the application.

Applications for special study rights at the University of Eastern Finland can be submitted any time between 1 August 2022 and 30 May 2023. Applications will be processed by the Faculties once per month, after the 15th day of the month. The separate study right applies to education provided in English by the Faculties of the University of Eastern Finland in accordance with the curriculum approved by the Faculty. Enrolment limitations may apply to some courses (such as a limit to the number of enrolments). The courses for which a special study right can be granted by the Faculty of Health Sciences are described in the Appendix on the Faculty's SharePoint site at: <https://studentuef.sharepoint.com/sites/TTopintojaksokuvaukset> (Path: English course offering 22-23; Course offering for separate study rights)

A study right granted by a Faculty shall not be limited to the education provided by the Faculty that granted it. The study right shall be granted for the Faculty whose education offering best corresponds to the student's prior studies. No tuition fees are charged for the education.

Separate study rights may be granted for studies beginning on or after 1 September 2022, and the rights are granted for one academic year at a time.

Granting of the title of docent in paediatric epidemiology to Ilari Kuitunen, MD

Ilari Kuitunen, MD, has proposed that he be awarded the title of docent in pediatric epidemiology in the University of Eastern Finland's Faculty of Health Sciences. The applicant's CV and list of publications are appended.

At its meeting, the Docent Committee of the Faculty of Health Sciences found that a docentship is appropriate in terms of teaching and research. The Dean of the Faculty of Health Sciences has invited Professor Kari Auranen (University of Turku) and Professor (emeritus) Harri Saxén (University of Helsinki) to issue expert statements on the scientific eligibility of Ilari Kuitunen, MD, for the docentship for which he has applied.

Under section 89 of the Universities Act (558/2009), the university may, upon application, award the title of docent (adjunct professor) to a person who has comprehensive knowledge of their field, a capacity for independent research or artistic work demonstrated through publication or some other manner, and good teaching skills.
