Faculty Councils will confirm the curricula and syllabuses of the teaching to be provided by the faculties in the next academic year in accordance with the schedule that is decided upon by the Rector each year. Curriculum or parts of it may be confirmed for several academic years at a time.

On 9 February 2023, the steering group of the Institute of Dentistry approved the curriculum and the syllabuses for the degree programme, as well as the amendments and additions made to the instructions. The curriculum for the degree programme includes the degree structure for students who will start their studies in 2023 and a summary of the syllabuses for the various years of the degree programme in dentistry for the academic year 2023–2024.

In addition, the below listed changes are proposed to the degree structure of those who started their studies in 2019–2022. The changes concern the evaluation, code, course description or credits of courses.

- Otorhinolaryngology-head and neck surgery, HL (4434020) has been moved from year four to year five. The course will not be arranged in the academic year 2023–2024 for dentistry students.
- Oral pathology II (4434035), 0.5 ECTS has been added, code changed to TL00DE70.
- Quit smoking -multiprofessionally (4427519), has been moved from year five to year four. In the academic year 2023–24, both fifth- and fourth-year students will take the course.
