Granting the title of docent to DSocSc Satu Valkonen

DSocSc Satu Valkonen has applied for the title of docent in Early Childhood Education, in particular Childhood Studies, at the University of Eastern Finland. The application for the title of docent was initiated on 22 December 2022 at the Philosophical Faculty of the University of Eastern Finland.

In accordance with section 89 of the Universities Act (558/2009), the university may award the title of docent upon application to a person who has comprehensive knowledge of his or her own field, a capacity for independent research or artistic work demonstrated through publications or some other manner, and good teaching skills.

The School of Applied Educational Science and Teacher Education has considered the docentship applied for by Valkonen to be purposeful for the teaching and research of the School based on the following grounds: "Valkonen's research focuses on the sustainable examination of childhood in a social and cultural context. The viewpoint is, in particular, interaction between the various institutions, media and families. The field of research is related to early childhood research carried out by the School of Applied Educational Science and Teacher Education and brings an important

addition to early childhood education from the perspective of sociallyoriented research in the early childhood education system and childhood. In addition, Satu Valkonen's research cooperation is already widely established within the University of Eastern Finland."

According to section 9 of the UEF University Regulations, the Faculty Council shall decide on awarding the title of docent.

The Dean of the Philosophical Faculty decided (on 24 January 2023) to invite Professor Sara Sintonen (University of Turku) and Professor Niina Rutanen (University of Jyväskylä) as experts to provide statements on the scientific qualification of DSocSc Satu Valkonen for the title of docent in early childhood education, in particular Childhood Studies. Sintonen and Rutanen, the experts appointed by the Dean, are in favour of awarding the title of docent to Valkonen.

Valkonen holds the following degrees: DSocSc in 2012 (University of Tampere), MSc in 2011 (University of Helsinki), MSocSc in 2003 (University of Tampere) and BEd in 2002 (University of Tampere). She has also completed pedagogical studies (60 ECTS) in 2011 (University of Helsinki) and obtained qualification to teach psychology in 2012 (University of Jyväskylä). Valkonen has worked in her current position as a university lecturer since 1 August 2018. Her previous roles include, e.g., a Senior Researcher in 2017–2018 (University of Helsinki), a Senior Designer and Developer of Media Education in 2012–2016 (Mannerheim League for Child Welfare) and a part-time researcher in 2015–2016 (PERLA - Tampere Centre for Childhood, Youth and Family Research).

A person to be awarded the title of docent is required to have good teaching skills (Universities Act, section 89). The Dean may exempt the applicant from the requirement to give a trial lecture if the teaching merits can be verified in some other manner in accordance with the faculty's instructions on awarding the title of docent. By its decision of 12 April 2023, the Dean has exempted Valkonen from the requirement to give a trial lecture and has determined her teaching merits on the basis of the application documents.

Motion

The Faculty Council states that DSocSc Satu Valkonen meets the criteria set for the title of docent in the Universities Act and awards Valkonen the title of docent in Early Childhood Education, in particular Childhood Studies at the University of Eastern Finland.
