## **Evaluation Report Promotion Application by Dr Antti Talonen**

The following is an assessment of the application by Dr Antti Talonen for appointment to the position of Assistant Professor/Associate Professor (Tenure Track) of responsible business management and co-operatives. I have reviewed Dr Talonen's CV, Teaching Portfolio, Work Plan, and accompanying selected publications. I have also read the position description of the job for which Dr Talonen is applying.

# Progress in research, academic career

Dr Talonen is an early career researcher, having completed his PhD in 2018. Since 2016 he has published at least 22 peer reviewed papers within a range of journals including; AMS Review, Journal of Co-operative Organization and Management, Journal of Financial Services Marketing, and the Risk Management and Insurance Review. He also has 9 papers in preparation or under review.

Three of his papers have achieved double-digit citations providing him with an h-g index of 5.5. This is above the average "5" of Assistant Professors, and if he continues to pursue this research trajectory (which seems likely given the work he has in the pipeline), he can be expected to soon match the average h-g index of "10" for Associate Professors.<sup>1</sup> Although his h-index is only 3, his g-index is 8, which is impressive given the relatively short time he has been publishing.

As someone who specialises in co-operative and mutual enterprise research, I have become familiar with Dr Talonen's work. I have found it well-considered, conceptually sound. He has leveraged his doctoral research into insurance mutuals but has also developed a coherent research focus within the field of CMEs that offers some valuable contributions.

#### International collaboration

Dr Talonen has also been active in developing an international network through his participation in, and organizing of, scientific conferences focusing on mutual enterprise. I note that since 2018 he has been a co-founder of the MIC-Conference, which has held forums in Croatia and Rome, and would have included Costa Rica if not for the impact of the COVID-19 pandemic. This demonstrates a strong capacity for collaboration at an international level.

It should also be noted that his engagement with numerous journals as a reviewer, and more recently as Editor-in-Chief of the *Journal of Co-operative Organization and Management*, also demonstrate this international collaboration work. Finally, Dr Talonen has been actively engaged as an invited speaker to a range of international events. For an early career researcher, he has demonstrated a high level of interest in and successful engagement with international network partners.

#### Research funding

I note that Dr Talonen has participated in, and provided leadership for, several research projects that have been supported by external funding. This has also led to his being able to leverage this funding to generate academic research papers. He has also received funding for industry outreach programs. It is clear that Dr Talonen has been active in the preparation of the applications for many of these grants.

#### **Academic leadership**

Given Dr Talonen's early career status he has demonstrated good academic leadership. This includes his role in taking on the Editor in Chief position of the *Journal of Co-operative Organization and Management*, which is becoming one of the leading journals within the co-operative and mutual enterprise research community. In addition, he has shown leadership in co-founding the MIC-Conference. As someone who has been involved in organizing international conferences, this is not an easy feat.

Dr Talonen's role as Managing Director of the Finnish Association of Co-operative Research, which he has undertaken since 2015, also demonstrates his leadership, as does his leadership roles in several research projects, where he has led the preparation of the funding application, and then taken a leadership role in the research work. I believe that Dr Talonen, given his early career status, had demonstrated an impressive level of academic leadership.

## Plan for development

Dr Talonen's work plan for his future development in the role is well considered and shows a detailed understanding of the co-operative and mutual enterprise research field. Having just recently published a book on the current state of the field of co-operative and mutual enterprise research, I believe that Dr Talonen's development plan is well-focused. Despite its long history, CME research remains marginalised within economics, management and business studies, and also sociology and history. It is fragmented and lacking in dedicated peer-reviewed journals. Dr Talonen's work plan aims to address many of these issues.

Progress in teaching activities

In relation to teaching activities Dr Talonen has, despite his relatively recent experience,

shown a strong capacity in the design, development, and delivery of university-level

courses, as well as industry outreach programs.

**Development in teaching** 

Dr Talonen's teaching work has also demonstrated a good understanding of the main

foundations of pedagogy and this is articulated in his Teaching Portfolio. He has taken

time to develop his teaching skills (e.g., completing of the program at Tampere University),

and also shown his awareness of the importance of developing his research supervision

skills.

Academic and societal impact

As noted earlier, Dr Talonen has been active in industry outreach programs, and also

being a member of several industry bodies (e.g., EIOPA) that allow him to apply his

expertise in financial services and insurance. In addition, he has been an invited speaker

to numerous national and international conferences and events, as well as publishing a

number of research papers and industry reports for professional and general communities.

This is commendable given the output he has also generated in the form of peer reviewed

literature in the same time frame.

Overall summary

Overall, I believe Dr Talonen is an impressive early career academic who is suitable for

the position that he has applied for. He meets all the criteria of the position, not only at the

level of Assistant Professor, but also for Associate Professor. I am confident that if he is

appointed, he will make a strong contribution to the faculty.
