§ 3

Proposal to the UEF Board on the student intake of the Philosophical Faculty in student admissions 2025–2028

According to section 14.2(10) of the Universities Act, the board of a public university is responsible for deciding on the number of students to be admitted to the university.

The schools/departments of the Philosophical Faculty have allocated the available study places in 2025–2028 as specified in the enclosed Appendix. The UEF Board will confirm the student intake (the maximum intake by faculty). The total student intake to be confirmed at faculty level will not be tied to study programmes, but the intake to each study programme will be confirmed when the admission criteria are approved or modified.

The Philosophical Faculty proposes to the UEF Board that it approves the student intake of the faculty to be a total of 1,400 study places in 2025–2028.

Motion

The Faculty Council of the Philosophical Faculty proposes to the UEF Board that it approves the student intake of the faculty to be a total of 1,400 study places in 2025–2028. More detailed student intake for each study programme will be confirmed annually when the admission criteria are approved or modified.

§ 4

Granting the title of docent to PhD Virpi Kaukio

PhD Virpi Kaukio has applied for the title of docent in Cultural Research, especially Environmental Aesthetics at the University of Eastern Finland. The application for the title of docent was initiated on 31 October 2023 at the Philosophical Faculty of the University of Eastern Finland.

In accordance with section 89 of the Universities Act (558/2009), the university may award the title of docent upon application to a person who has comprehensive knowledge of his or her own field, a capacity for independent research or artistic work demonstrated through publications or some other manner, and good teaching skills.

The School of Humanities has considered the title of docent applied for by Kaukio to be purposeful for the teaching and research of the School based on the following grounds: "Kaukio's expertise complements the competence of the School of Humanities in the fields of humanistic environmental research and aesthetic research. The School of Humanities does not have a professor of environmental aesthetics, but research on the subject is actively carried out, as is humanistic environmental research. As regards global challenges, humanistic environmental research is also a very relevant and topical field of research. For this reason, Virpi Kaukio's area of expertise is a necessary addition to the research, supervision and education of the study programme."

The Dean of the Philosophical Faculty decided (on 22 November 2023) to invite Docent Max Ryynänen (Aalto University) and Docent Helena Lonkila (University of Jyväskylä) as experts to provide statements on the scientific qualification of PhD Virpi Kaukio for the title of docent in Cultural Research, especially Environmental Aesthetics. Both experts are in favour of awarding the title of docent to Kaukio.

A person to be awarded the title of docent is required to have good teaching skills (Universities Act 558/2009). PhD Virpi Kaukio's teaching skills were assessed on the basis of a trial lecture given on 19 February 2024. She has the good teaching skills required for the post.

According to section 9 of the UEF University Regulations, the Faculty Council shall decide on awarding the title of docent.

The applicant meets the qualification requirements of a docent specified in section 89 of the University Act and the criteria set out in the docentship guidelines of the Philosophical Faculty for the title of docent.

Motion

The Faculty Council states that PhD Virpi Kaukio meets the criteria set for the title of docent in the Universities Act and awards Kaukio the title of docent in Cultural Research, especially Environmental Aesthetics at the University of Eastern Finland.
