§ 3

The Dean's proposal to the Rector of the University of Eastern Finland on the appointment of MD Harri Hyppölä to the part-time (30%) post of Professor of Health Care until further notice: Hearing of the Faculty Council

By his decision, the Dean of the Faculty of Health Sciences has approved the description of the post of Professor/Associate Professor of Health Care.

Two applicants applied for the vacant part-time (30%) post of Professor/Associate Professor by the deadline (Annex), but only Harri Hyppölä meets the qualification requirements set for the post.

In accordance with the Universities Act, statements must be requested before the appointment on the qualification and merits of the applicants or the person to be invited to the post from a minimum of two experts when a person is being recruited for an employment relationship that will be effective until further notice or for a fixed period of at least two years. Sections 27–29 of the Administrative Procedure Act (434/2003) on disqualification shall be applied to the experts.

According to the University Regulations of the University of Eastern Finland, a person to be appointed as Professor shall be scientifically or artistically qualified, have good teaching skills and, if important for attending to the duties, have practical familiarity with the field of the post.

By decision of the Dean of the Faculty of Health Sciences, the person to be appointed to the post of Professor of Health Care is required to have practical familiarity with the field of the post. Practical familiarity is considered to mean that the person has a specialist degree or is a qualified specialist in health care and has at least two years' experience of working as a medical specialist.

Expert statements on the eligibility and merits of the person applying for the post have been requested from the following persons: Professor Kristiina Patja (University of Helsinki) and Päivi Rautava (University of Turku).

Based on the application documents, expert statement, and an interview, the Appointments Committee proposes that MD Harri Hyppölä be appointed to the open part-time (30%) post of Professor of Health Care as of 1 November 2024 until further notice. The proposal of the Appointments Committee and the application documents are enclosed with this agenda item as appendices.

According to section 10(9) of the University Regulations of the University of Eastern Finland, the Dean shall make a proposal to the Rector on the person to be appointed to the post after hearing the Faculty Council.

Harri Hyppölä is not required to give a trial lecture.

§ 4

The Dean's proposal to the Academic Rector on the person to be appointed as University Lecturer, Food Science: Hearing of the Faculty Council

According to the UEF University Regulations, the Dean shall make proposals to the Rector on the persons to be appointed to professorships with a term of two years or over, to permanent teaching and research positions compliant with the four-stage research career model and to Tenure Track positions after hearing the Faculty Council.

In accordance with the regulations of the University of Eastern Finland, the Dean will make a proposal to the Academic Rector on the fulfilment of posts, excluding professors, that comply with the four-stage career model.

A call for applications was organised for the post of University Lecturer (Food Science) that will be effective until further notice by the Institute of Public Health and Clinical Nutrition of the University of Eastern Finland's School of Medicine.

Three applicants applied for the post by the deadline: PhD Heikki Aisala, PhD Carolin Kolmeder and PhD Kati Väkeväinen.

Persons to be appointed as University Lecturers must hold a suitable doctoral degree and have good teaching skills (University Regulations).

Members of the university's teaching and research staff are required to have command of the language they give teaching in (Finnish or Swedish) (Government Decree on Universities 770/2009). The Dean of the faculty can grant an exemption from the language proficiency requirements laid down in the Government Decree on Universities (UEF University Regulations).

Two of the applicants have the required doctoral degree that is suited to the post, as well as merits and achievements related to teaching and research.

The Appointments Committee states (Appendix) that all applicants have a suitable doctoral degree that is required for the post, at least good Finnish skills and are also able to teach in English. Väkeväinen is the only applicant who has completed university pedagogy studies and has more extensive experience in university education, student admissions and the coordination of continuous learning.

The Appointments Committee proposes that PhD Kati Väkeväinen be appointed to the post of University Lecturer (Food Science) from 1 January 2025 onwards until further notice.

Kati Väkeväinen received a Master's degree (Nutrition and Food Biotechnology) in 2010 and a Doctoral degree (Nutrition) in 2020 from the University of Eastern Finland.

Grading MSc (Food Science), MHSc Kirsikka Aittola's doctoral dissertation

According to section 9 of the University Regulations of the University of Eastern Finland (1 January 2024), the Faculty Council grades doctoral dissertations. According to Section 14 of the standing rules of the Faculty of Health Sciences on degrees and studies, doctoral dissertations are graded on the scale fail – pass – pass with distinction. Passing with distinction requires that two of the three examiners (preliminary examiners and opponent) propose this grade.

MSc (Food Science), MHSc Kirsikka Aittola's doctoral dissertation and study "Eating competence and the Healthy Diet Index. Novel approaches for the prevention of type 2 diabetes" was examined publicly on 6 September 2024. The opponent, Professor Emeritus Markku Savolainen (University of Oulu) is in favour of the dissertation being approved as a thesis for a doctoral degree in Health Sciences and proposes the grade Pass. Both preliminary examiners, PhD Marjukka Nurkkala (University of Oulu) and Docent Noora Kanerva (University of Helsinki) are in favour of the dissertation being approved as a thesis for a doctoral degree in health sciences and propose the grade Pass.

According to section 44 of the Universities Act (24.7.2009/558), before a doctoral dissertation is graded, the author must be given an opportunity to submit his or her response to the preliminary examiner's, the

examiner's or the opponent's statement. The doctoral candidate has no comments on the statements. The statements of the preliminary examiners and the opponent are enclosed with this agenda item as appendices.

According to section 29 of the Universities Act (24.7.2009/558), a study attainment may be assessed only by those members or deputy members of a multi-member administrative body who have a degree or completed study attainments of an equivalent level or who have been appointed professors.

According to section 9 of the University Regulations of the University of Eastern Finland (1 January 2024), the Faculty Council grades doctoral dissertations. According to Section 14 of the standing rules of the Faculty of Health Sciences on degrees and studies, doctoral dissertations are graded on the scale fail – pass – pass with distinction. Passing with distinction requires that two of the three examiners (preliminary examiners and opponent) propose this grade.

MB Minna Harmanen's doctoral dissertation and study "Mantle cell lymphoma in the rituximab era: Retrospective registry study on survival, treatment and prognostic factors", was examined publicly on 13

September 2024. According to section 29 of the Universities Act (24.7.2009/558), a study attainment may be assessed only by those members or deputy members
