§ 3

Description of the post of Professor, Pharmacoepidemiology and Real World Data Analytics, and the Dean's proposal to invite Professor Anna-Maija Tolppanen to the post: Hearing of the Faculty Council

The School of Pharmacy of the University of Eastern Finland has proposed in its strategic human resources plan that Anna-Maija Tolppanen be invited to the post of Professor, Pharmacoepidemiology and Real World Data Analytics until further notice.

Anna-Maija Tolppanen received a Master's degree from the University of Kuopio in 2005 and a PhD from the University of Kuopio in 2009. She was awarded the title of docent in analytical epidemiology at the University of Eastern Finland in 2012.

The proposed grounds for the invitation procedure are:

Anna-Maija Tolppanen is currently Professor of Effectiveness in Healthcare at the School of Pharmacy of the University of Eastern Finland. Her previous roles include Academy Research Fellow at the University of Eastern Finland (2016–2021) and Associate Professor (2015–2019), Director of Development (2013–2015), Postdoctoral Researcher (2011–2013) and Researcher at the University of Bristol (2006–2009).

Anna-Maija Tolppanen's list of publications includes 178 international peer-reviewed original scientific articles. She has supervised eight doctoral dissertations and is currently supervising nine more, in 12 of which she is the main supervisor. Anna-Maija Tolppanen has, either alone or as a member of a consortium, acquired almost EUR 1.5 million of research funding.

Anna-Maija Tolppanen's CV and list of publications are enclosed with this agenda item as Annex 1.

On the basis of the above, Docent Anna-Maija Tolppanen fulfils the requirements of the invitation procedure for the post of Professor, Pharmacoepidemiology and Real World Data Analytics.

According to section 33 of the Universities Act (558/2009), the professorship may be filled by invitation without a public notice of vacancy when an academically distinguished person is being invited to take the position or a candidate is appointed to the position for a fixed period. Only a person who indisputably fulfils the qualification requirements may be appointed to the post by invitation.

§ 4

Description of the post of Professor, Bioanalytics and Molecular Epidemiology, and the Dean's proposal to invite Research Director Mika Ala-Korpela to the post: Hearing of the Faculty Council

The School of Pharmacy of the University of Eastern Finland has proposed in its strategic human resources plan that Mika Ala-Korpela be invited to the part-time (20%) post of Professor, Bioanalytics and Molecular Epidemiology, until further notice.

The proposed grounds for the invitation procedure are:

Mika Ala-Korpela received a Master's degree from the University of Kuopio in 1988 and a PhD from the University of Oulu in 1994. He was awarded the title of docent in biological NMR at the University of Kuopio in 1997.

Mika Ala-Korpela is currently a Research Director at the University of Eastern Finland and a Professor at the University of Oulu. His previous roles include a Professor at the University of Eastern Finland (2018–2021) and at the University of Bristol (2013–2019). He has plenty of international experience of working in various positions abroad, including at the University of Valencia, Spain; National Health and Medical Research Council, Baker Heart and Diabetes Institute and Monash University, Australia; and Central South University, China.

Mika Ala-Korpela's list of publications includes 275 peer-reviewed international scientific publications. He has supervised 13 doctoral dissertations and is currently supervising two more.

Mika Ala-Korpela has acquired more than EUR 7 million of research funding as a principal researcher since 2009. He has also participated in several consortium projects, whose combined total value exceeds EUR 70 million.

On the basis of the above, Mika Ala-Korpela meets the requirements of the invitation procedure for the part-time (20%) post of Professor, Bioanalytics and Molecular Epidemiology.

According to section 33 of the Universities Act (558/2009), the professorship may be filled by invitation without a public notice of vacancy when an academically distinguished person is being invited to take the position or a candidate is appointed to the position for a fixed period. § 5

Description of the post of Professor/Associate Professor of Medical Biochemistry (Tenure Track): Hearing of the Faculty Council

According to section 9 of the University Regulations of the University of Eastern Finland, the Faculty Council will discuss proposals regarding the scope and specifications of posts that comply with the four-stage career model of the faculty's permanent teaching and research staff and Tenure Track positions.

In their strategic human resources plan, the School of Medicine and the Institute of Biomedicine of the University of Eastern Finland propose that the post of Professor/Associate Professor of Medical Biochemistry (Tenure Track) be filled at the institute.

The post will be hosted by the Faculty of Health Sciences, the School of Medicine, the Institute of Biomedicine.

According to the University Regulations of the University of Eastern Finland, a person to be appointed to a professorship shall be scientifically or artistically qualified, have good teaching skills and, if important for attending to the duties, have practical familiarity with the field of the post.

A person to be appointed as an associate professor in the tenure track in accordance with the University Regulations of the University of Eastern

Finland shall hold a suitable doctoral degree and have good teaching skills. Furthermore, the person shall have the prerequisites to fulfil the qualification requirements of a professor by the end of the tenure track term.

The post of a Professor will be filled until further notice starting on 1 January 2026 at the earliest. In the case of an Associate Professor (Tenure Track), the post will be filled for a four-year term starting on 1 January 2026 at the earliest. The post is filled for a fixed term due to it being a Tenure Track position.

The criteria, goals and results to be achieved during the term in order to proceed to the next level of the Tenure Track (Professor) will be agreed upon in detail with the person appointed to the Associate Professor position when the contract of employment is signed.

The description of the post of Professor/Associate Professor (Tenure Track) (Annex) includes the scope and specifications of the post as required by the UEF University Regulations.

To be able to work as dentists in Finland, persons who have completed their dentist education outside the EU/EEA, must have been granted the right to practise the profession in Finland by Valvira. The University of Turku and the University of Eastern Finland provide preparatory training for the qualification process. Education does not lead to a degree. Four (4) places have been proposed for the training implemented at the University of Eastern Finland. The duration of the training is 4.5 months (08/2025–12/2025) and it includes on-campus and remote teaching provided in Finnish. The admission criteria for the education have been approved by the Faculty Council in February 2025 (record entry 253/03.01.00/2025).

The Institute of Dentistry of the School of Medicine has prepared a proposal for the curriculum for the training preparing dentists who have completed their degree outside the EU/EEA for competency examinations. The curriculum is enclosed with the agenda as Annex.

Approving the student admission criteria and curriculum for the qualification training of immediate supervisors in social and healthcare for the academic years 2025–2028 and the curriculum for the leadership training of specialising physicians/dentists

According to section 9 of the University Regulations of the University of Eastern Finland, the Faculty Council will make decisions concerning curricula, degree requirements and admission criteria. The nationally uniform curricula and examination requirements for specialist education in medicine and dentistry that comply with Amendments 55/2020 and 1240/2022 of the Decree of the Ministry of Social Affairs and Health were approved by the Faculty Council on 14 June 2023. The national curricula define the learning outcomes and themes of the mandatory leadership studies (10 ECTS) that are included in the specialist education in medicine and dentistry.

In accordance with the national guidelines, the mandatory leadership studies of 10 ECTS included in the specialist education in medicine and dentistry will, in future, be called the leadership studies of specialising physicians/dentists. The curriculum is presented in more detail in Annex 1.

At the Faculty of Health Sciences of the University of Eastern Finland, the School of Medicine provides dentists and physicians who are either conducting or have already completed specialisation studies with the opportunity to complete studies that qualify them to act as immediate

supervisors in social and healthcare. The study module (20 ECTS) supplements the mandatory leadership studies included in the specialisation studies in medicine and dentistry (10 ECTS), constituting a module that gives qualifications to act as an immediate supervisor (30 ECTS in total). The module provides the skills to act as an immediate supervisor in social and health care units. Annex 2 contains the admission criteria and curricula for the study module for the academic years autumn 2025–spring 2028.
