# Grading MEd Assi Kukkonen's doctoral dissertation in the field of Sociology of Education

According to section 9 of the University Regulations of the University of Eastern Finland (1 August 2018), the Faculty Council grades doctoral dissertations. According to the instructions issued separately by the Philosophical Faculty (24 May 2023), doctoral dissertations are graded on the scale fail – pass – pass with distinction.

MEd Assi Kukkonen's doctoral dissertation and study "Pahantapaisesta kelpo mieheksi. Tutkimus rangaistusten käytöstä Koivikon kasvatuslaitoksessa toiminnan alkuvaiheissa vuosina 1885–1920" was examined publicly on 31 January 2025. The opponent Professor emeritus Hannu Simola (University of Helsinki) is in favour of the dissertation being approved as a thesis for a doctoral degree in Education and proposes the grade Pass.

According to section 44 of the Universities Act (24.7.2009/558), before a doctoral dissertation is graded, the author must be given an opportunity to submit his or her response to the preliminary examiner's, the examiner's or the opponent's statement. The doctoral candidate has no comments on the statement. The statements of the opponent and the custos are enclosed with this agenda item as annexes.

According to section 29 of the Universities Act (24.7.2009/558), a study attainment may be assessed only by those members or deputy members of

## Approval of the curricula for Bachelor's and Master's level education 2025–2028 and transitional rules

According to section 9(4) of the University Regulations of the University of Eastern Finland, the Faculty Council shall decide on curricula. According to section 18 of the Education Regulations, the curriculum of each degree programme must indicate, among others, the degree the scientific and professional objectives of the education; the degree structure (including the courses and their scopes), learning outcomes, contents, methods of completion and assessment of the degree and its parts, the names of the degrees, study modules and courses in Finnish and English, and the course descriptions in the language of instruction of the course.

According to section 3 of the Education Regulations, on the basis of a proposal by the head responsible for education of a school or a department, the Faculty Councils shall confirm the admission criteria as well as the curricula and syllabi for the faculties' teaching in the next academic year, in accordance with an annual schedule approved by the Vice Rector for Education.

According to the decision of the Academic Rector (17/2024, 26.4.2024), the faculty councils will confirm curricula (incl. course descriptions) by the end of February.

According to the decision, the course offering, which will be confirmed by the end of March, will be introduced as a new phase of syllabus description.

The availability of courses in the next academic year will be confirmed in the course offering: semester(s) when implemented or, if desired, the study period(s). According to Decision 284/2024 of the Vice Dean of the Philosophical Faculty (29 August 2024), it is confirmed at the same time whether the teaching is organised on campus or remotely. According to the decision of the Academic Rector, the Faculty Council may, when deciding on the curriculum, delegate decision-making related to the course offering to the Dean/the Dean in charge of education.

According to the decision of the Academic Rector, syllabi are confirmed by the end of May. The Faculty Councils may delegate decision-making on the curriculum to the Heads of departments and schools /the Director responsible for education.

On 26 January 2022, the Faculty Council of the Philosophical Faculty delegated its decision-making powers in curricula matters: The confirmation of the curriculum has been delegated to the Vice Dean in charge of education. Minor changes to curricula during the academic year are approved by the Vice Dean. Changes to the curriculum during the academic year are approved by the head responsible for education of the school.

The pedagogical leaders of the schools have presented the curricula of the schools for the academic years 2025-2028 and transitional rules for the approval of the Faculty Council.

The post of University Lecturer, Literature, is located in the School of Humanities. Filling the post through direct recruitment is the most appropriate option from the point of view of the School.
