# Granting the title of docent to PhD Juuso Honkanen in the field of Medical Physics, in particular Orthopaedic Contrast-Enhanced Computed Tomography

PhD Juuso Honkanen has applied for the title of docent in the field of Medical Physics, in particular Orthopaedic Contrast-Enhanced Computed Tomography, at the Department of Technical Physics of the Faculty of Science, Forestry and Technology of the University of Eastern Finland. PhD Honkanen's application and related attachments are enclosed with the agenda item as annexes.

In accordance with section 89 of the Universities Act 558/2009, the university may award the title of docent upon application to a person who has comprehensive knowledge of his or her own field, a capacity for independent research or artistic work demonstrated through publications or in some other manner, and good teaching skills.

According to section 9(8) of the University Regulations of the University of Eastern Finland, the Faculty Council shall decide on awarding the title of docent.

By a decision dated 29 January 2025, the Dean of the Faculty of Science, Forestry and Technology appointed Professor Harrie Weinans



(Department of Orthopedic Surgery, University Medical Center Utrecht, Utrecht, the Netherlands) and Docent, Chief Physicist Juha Nikkinen (Research Unit of Health Sciences and Technology, Oulu) to submit their expert statements on the scientific qualifications of PhD Juuso Honkanen in order to be awarded the title of docent in the field of Medical Physics, in particular Orthopaedic Contrast-Enhanced Computed Tomography. Professor Weinans and Docent, Chief Physicist Nikkinen have stated that PhD Honkanen is scientifically qualified in the field that his title of docent application concerns. By a decision dated 28 January 2025, the Dean has exempted Honkanen from the requirement to give a trial lecture and has determined his teaching merits based on the application documents.
