§ 6

Discontinuation of licentiate education and transitional rules

According to section 9 of the UEF University Regulations, the Faculty Council shall decide, within the scope of the faculty's educational responsibility, on the launch of a new major subject and shutting down of an existing one, and on curricula and student admission criteria.

According to section 6 of the Education Regulations: When a degree programme is discontinued, the faculty must provide students who have been granted a right to study in it with the opportunity to complete their studies. The Faculty Council will decide on the transitional arrangements. The right to study in the discontinued degree programme ends at the end of the transitional period.

The Research Council of the Philosophical Faculty proposes that the Faculty's licentiate education be discontinued. Those who have been granted the right to pursue a Licentiate degree have a two-year period to complete the degree in accordance with the requirements of the scientific Licentiate degree. The two-year period is calculated from 1 January 2026. The transitional period ends on 31 December 2027, when the right to study in the discontinued degree programme ends. At the end of the transitional period, a Licentiate degree cannot be completed with study rights for doctoral studies either.

Universities have started to direct postgraduate students to pursuing a doctoral degree directly. In practice, this means that licentiate degrees are no longer actively offered and no calls are being organised to them.

Licentiate degrees have been removed from the funding model of universities, which has reduced their strategic importance in the activities and steering of higher education institutions. It has been possible for those with a study right for doctoral studies to completed a licentiate thesis and degree, if completing the doctoral dissertation has not seemed probable.

At the present time, the Philosophical Faculty has 88 valid separate study rights for a licentiate degree. The study rights were granted between 1972–2010. Of these, only six students have registered as being present in autumn 2025 and 82 have not registered at all. Some of these study rights have been granted for professional licentiate education in the fields of education and humanities; this training has not been organised after 2010. Some of the study rights have been granted for completing a scientific licentiate degree. It has still been possible to complete a scientific licentiate degree in accordance with the current degree requirements. In 2020–2025, a total of three licentiate degrees were completed at the Philosophical Faculty.

Motion

The Faculty Council will decide on the discontinuation of licentiate education of the Philosophical Faculty and on the transition period. Those who have been granted the right to pursue a Licentiate degree have a two-year period to complete the degree in accordance with the requirements of the scientific Licentiate degree. The two-year period is calculated from 1

January 2026. The transitional period ends on 31 December 2027, when the right to study in the discontinued degree programme ends. The Faculty Council will delegate any clarifications and corrections to the Dean or to the Vice Dean responsible for research.

§ 7

Descriptions, assessment criteria and assessment scales of doctoral dissertations at the Philosophical Faculty

The Research Council of the Philosophical Faculty has submitted to the Faculty Council for confirmation a proposal on the descriptions, assessment scales, assessment criteria and assessment process of doctoral dissertations that will be valid from 1 January 2026.

Dissertation instructions have been reformed based on national recommendations and the needs of the research community. No changes are proposed to the requirements of doctoral dissertations and licentiate theses. The now proposed reforms are recommendations that concern the length of monographs and the content and length of the abstract of article-based theses. The formulation of the text has also been clarified. The assessment criteria have been reorganised to some extent and the criteria that were previously included in the preliminary examiner's instructions have been written out. The general content has remained the same.

The Faculty Council will approve the descriptions, assessment scales, assessment criteria and assessment processes of doctoral dissertations as proposed, and will delegate any clarifications and corrections to the Dean or the Vice Dean responsible for research.

§ 8

Deciding on the criteria for student admissions to minor subject studies organised by the Philosophical Faculty and the number of students to be admitted in 2026

According to section 12 of the Education Regulations of the University of Eastern Finland, the Philosophical Faculty shall organise pedagogical studies that lead to a teacher's qualification, decide on the admission criteria for these students (incl. subject-specific intake) and grant the study rights. The Faculty of Health Sciences shall organise teacher training in health sciences for students who major in nursing science.

According to section 13 of the Education Regulations, minor subjects may be studied freely at the university with the exception of fields which require an aptitude or proficiency test for student admission, or which have other justified reasons for restricting the right to study minor subjects. Any restrictions on the right to study minor subjects shall be laid down in the curriculum.

The pedagogical leaders of the School of Humanities, the School of Educational Sciences and Psychology and the School of Applied Educational Science and Teacher Education have proposed that the curricula be supplemented with the restrictions on the right to study minor subjects in accordance with the enclosed admission criteria for minor subject studies.

The budget of the Philosophical Faculty for 2026 and financial outcome for 2025

According to section 9(2) of the University Regulations of the University of Eastern Finland, the Faculty Council addresses the starting points of the faculty's budget preparation and operational planning, as well as financial performance reports and the budget. The budgets of faculties, independent institutes and service centres constitute the university's official budget for 2026, which will be inspected by the Board of the University of Eastern Finland at its meeting of 12 December 2025 (section 3 of the UEF University Regulations).

Budget for 2026

The funding of the faculty is allocated in accordance with the principles verified by the Board for the internal allocation of funds. The financial contribution of the Philosophical Faculty consists of:

- Indicator-based funding
- Funding for additional study places
- National special duties
- Strategic funding and equalisation instalments

The core funding also includes funding for the doctoral pilots, which will be treated as a separate instalment in accordance with the conditions of

the pilots. The additional impact of doctoral pilots in 2026 is estimated to be up to EUR 85,000.

In the faculty's internal distribution of funds, the university's revenue model will be followed, which is to be transformed into a research-oriented 50/50 model by a joint decision of the faculty's management group.

The target level of external funding at the Philosophical Faculty in 2026 is EUR 10 million (previously EUR 8 million).

Financial outcome for 2025

Financial reporting will monitor the implementation of the official budget of the university confirmed by the Board during the year. The report includes internal revenues and expenses. Three times a year, the realisation of the budget will be reviewed: for January-April, January-August and January-December. The realisation is based on accounting. The faculty's analysis and forecast of the realisation of the budget constitute part of the reporting. The first two reports also include a forecast of the result for the financial year.

In August, the faculty's expected result complies with the budget.
