For information, the indicator-based funding model, the allocation of the faculty's basic funding in 2026 and the preliminary result for 2025

The funding of the faculties has been allocated in accordance with the principles verified for the internal allocation of funds by the Board. The funding of the faculties consists of indicator-based funding, funding based on the strategic programmes of the university, and other agreed items allocated based on strategic principles.

The basic funding of the Faculty of Social Sciences and Business Studies for 2026, totalling EUR 22.8 million, consists of:

- funding allocated through the indicator-based funding model
- funding for additional study places
- strategic funding allocated by the University
- strategy-based funding of the faculties/equalisation instalments

The faculty's internal distribution of funds follows the indicator-based funding allocation model, where the weighting of education indicators is 50% and the weighting of research indicators is 50%.

The curriculum and student admission criteria for the specialist field of welfare services of the specialisation studies in social work

Specialisation studies mean long-term education completed after a university degree and aimed at persons with working experience to promote professional development and specialisation. The aim of the education is to meet the skills needs specified jointly by higher education institutions and working life actors. The goals of the education are regulated in the Government Decree on University Degrees and Specialisation Education (794/2004, section 20a).

In Social Work, specialisation training is provided in four fields: 1) Adult social work and social rehabilitation, 2) Welfare services, 3) Child, youth and family social work, and 4) Structural social work. The trainings are prepared by Sosnet – the Finnish National University Network for Social Work.

Studies in the field of welfare services will be organised jointly by the University of Eastern Finland and the University of Helsinki between 2027 and 2029. The studies will be implemented as blended teaching, making use of digital learning environments so that it can be completed alongside working. The training is targeted at social workers who have completed a

Master's degree at a university (Act on Social Welfare Professionals 817/2015, section 7), who have the right to practise and experience in social work.

The State may compensate costs resulting from the training to the university that organises specialisation studies in social work (Sections 60a and 60b of the Social Welfare Act 1301/2014), but only if no tuition fee has been charged for the studies. Therefore, no tuition fees are to be charged for the now addressed trainings.

According to section 9(4), subsection 6 of the University Regulations of the University of Eastern Finland, the Faculty Council will make decisions concerning curricula, degree requirements and student admission criteria.

1. The Faculty Council approves the admission criteria and student intake (17) of the specialist field of welfare services in accordance with Appendix 1. At the University of Eastern Finland, the training will be organised if there are at least eight students (8). No tuition fees will be charged for the training.

Master's degree programme in Social Work in Kymenlaakso: approval of the curriculum and student admission criteria

The University of Eastern Finland, the City of Kouvola and the Wellbeing Services County of Kymenlaakso have concluded a cooperation agreement on the organisation of Master's degree studies in Social Work in Kymenlaakso. Master's level education in Social Work will be implemented in the period from 1 August 2026 to 31 December 2028. The education has been planned in cooperation with the University of Eastern Finland and the Wellbeing Services County of Kymenlaakso. Contact teaching included in the degree will be organised in Kouvola as daytime education. A total of 25 students who major in social work will be admitted in separate admissions organised in spring 2026 to pursue a Master of Social Sciences degree.

Granting the title of docent to LLD Joonas Alaranta

LLD Joonas Alaranta has applied for the title of docent in Law, especially Chemicals Law, at the University of Eastern Finland. The application for the title of docent was initiated on 03 June 2025 at the Faculty of Social Sciences and Business Studies of the University of Eastern Finland.

In accordance with section 89 of the Universities Act (558/2009), the university may award the title of docent upon application to a person who has comprehensive knowledge of his or her own field, a capacity for independent research or artistic work demonstrated through publications or some other manner, and good teaching skills.

The Law School has considered the title of docent applied for by LLD Joonas Alaranta to be purposeful for the teaching and research of the School based on the following grounds: "Alaranta is a specialist of chemical law, which is a key area of education in environmental law. The School does not have corresponding expertise and, therefore, Alaranta's title of docent supports the School's education in environmental law in an excellent manner. As an expert in chemical law, Alaranta is an excellent partner for research projects. In addition, Alaranta's application is

preceded by concrete educational and research cooperation, which has served the needs of the School.”

The Dean of the Faculty of Social Sciences and Business Studies decided to invite Associate Professor Tiina Paloniitty (University of Helsinki) and Professor, Emerita Anne Kumpula (University of Turku) as experts to provide statements on the scientific qualifications of LLD Joonas Alaranta for the title of docent in Law, especially Chemicals Law. Both experts are in favour of awarding the title of docent to Alaranta.

A person to be awarded the title of docent is required to have good teaching skills (Universities Act 558/2009). The Dean may exempt the applicant from the requirement to give a trial lecture if the teaching merits can be verified in some other manner in accordance with the faculty's instructions on awarding the title of docent. By a decision of 6 February 2026, the Dean has exempted Alaranta from the requirement to give a trial lecture and has determined his teaching merits based on the application documents.

According to section 9 of the UEF University Regulations, the Faculty Council shall decide on awarding the title of docent.

The applicant meets the qualification requirements specified in section 89 of the Universities Act and the criteria set out in the docentship guidelines of the Faculty of Social Sciences and Business Studies for the title of docent.

Description of the post of Professor, Tourism Business, Business School, and the Dean's proposal to invite DSc (Econ.) Henna Konu to the post: Hearing of the Faculty Council

According to section 33 of the Universities Act (558/2009), the professorship may be filled by invitation without a public notice of vacancy when an academically distinguished person is being invited to take the position or a candidate is appointed to the position for a fixed period. Only a person who indisputably fulfils the qualification requirements may be appointed to the post by invitation.

According to section 31 of the University Regulations of the University of Eastern Finland, a person to be appointed to a permanent professorship or to a professorship that lasts for over two years shall be scientifically or artistically qualified, have good teaching skills and, if important for the successful performance of their duties, practical knowledge of the scope of the post.
