Admission criteria for and the student intake to specialist education in medicine and dentistry for the academic year 2026–2027

According to section 9(4) of the University Regulations of the University of Eastern Finland, the Faculty Council will make decisions concerning curricula, degree requirements and student admission criteria. Decree 56/2015 of the Ministry of Social Affairs and Health (amended with Decree 55/2020 and Decree 1240/2022) specify the requirements for being accepted to further professional education and the admission criteria. As regards professional further education, the nationally agreed upon common practices will be followed.

The faculties that provide professional further education in medicine and dentistry in Finland have prepared admission criteria for specialist education in medicine and dentistry in the spring of 2026. Appendix 1 includes a proposal on the admission criteria for the academic year 2026–2027 for the approval of the Faculty Council. The key changes are:

Changes to initial scoring

- The initial score will be taken into account up to the day preceding the start of each admission round.
- In JUFO scoring, the classification that is valid during the application period is, as a rule, applied; the classification of the year of

publication can be taken into account based on a separate clarification submitted by the applicant.

- The weighting of the scoring for the general practice YES course has been changed (no effect on the total score).

- The interview is not necessary if there is no competition in the degree programme.

Changes concerning specialist education in dentistry (EHL) only

- The right to practise independently (the so-called full license; not a temporary or limited license issued by the Finnish Supervisory Agency or Valvira) is also required for the accumulation of 2 years of clinical work experience.
- For the work to be included in the 2 years of clinical work experience, the part-time percentage must be at least 20% of the total working time. The shortest acceptable single working period is one month of full-time work (a calendar month or 30 days).
- The specialist-field -specific scoring has been modified: 1 point / 2 months (previously 1 point / 1 month)
- The person in charge will check the specialist field points in all EHL degree programmes before the person is invited to interview.

Appendix 2 shows the student intake of each specialist field at the University of Eastern Finland for the academic year 2026–2027. The proposal is based on the national assessment of the need for education by an expert group appointed by the Ministry of

Social Affairs and Health and on the assessments of the persons responsible for the specialist fields on the regional need for education.

Exceeding the student intake requires a proposal of the specialist field and the approval of the Professional Further Education Committee (AJT). The Dean will make the related decision.

General educational requirements, specialist field -specific curricula and examination requirements for specialist education in medicine and dentistry as of 1 August 2026

According to section 9(4) of the University Regulations of the University of Eastern Finland, the Faculty Council will make decisions concerning curricula, degree requirements and student admission criteria. The general educational requirements, specialist field-specific curricula, skills assessment methods and examination requirements for specialist education in medicine and dentistry were prepared during the spring 2026 in national cooperation by the five Finnish universities that provide medical training.
